

PROBLEM STATEMENT



11. Consider temporary off-site storage if a family member may be suicidal. When there is an emotional crisis (like a break-up, job loss, legal trouble) or a major change in someone's behavior (like depression or anger, more drinking) that causes concern, storing guns outside the home until the situation improves may save a life. Friends, shooting clubs, police departments, and some firearms stores may provide storage services.





RESEARCH – KEY FINDINGS

Interviews with 100 stakeholders showed support for concept but concerns about liability and funding/logistics (PMID: 35224749)


27% of people in homes with firearms had stored them away from home in past 5 years (PMID: 36915179)

45% of firearm ranges/retailers in two states had provided storage (PMID: 36037869)

OPEN LETTER TO ALL FEDERAL FIREARMS LICENSEES PROVIDING FIREARM STORAGE FOR INDIVIDUALS

On March 14, 2023, President Biden issued an Executive Order 14092 on Reducing Gun Violence and Making Our Communities Safer. Among other things, that order emphasized the need for Federal agencies to promote the safe storage of firearms. The Bureau of Alcohol, Tobacco, Firearms and Explosives ("ATF") is issuing this open letter to assist Federal Firearms Licensees ("FFLs") in understanding their obligations when they choose to provide firearm storage services to their customers and the public.

Individuals may seek the services of an FFL to store firearms for a variety of reasons. For example, an individual might wish to store a firearm while traveling to a neighboring State or foreign country that does not permit possession of the firearm. Storage of firearms at an FFL's business premises may also be desirable or convenient for an individual, or may allow an individual to temporarily remove firearms from a home. FFLs can assist in such cases if they adhere to applicable Federal, State, and local laws when storing and returning such firearms.



RESEARCH – KEY FINDINGS





HB 260 IN LOUISIANA

"No person shall have a cause of action against a federal firearms licensee operating lawfully in the state of Louisiana for any act or omission arising from a firearm hold agreement and resulting in personal injury or death of any natural person, including the return of any firearms to the individual firearm owner by a federal firearms licensee at the termination of a firearm hold agreement."



HB 1181 IN WASHINGTON

"A dealer who provides a service of allowing a person to temporarily store a firearm on the dealer's premises in a storage locker, box, or container that is locked and not accessible to the dealer does not thereby create a special relationship, for civil liability purposes, between the dealer and the person who temporarily stores the firearm on the dealer's premises."

EQUITY IMPACT

"What I try to keep in mind is that some of the alternatives, for example, for storage, are not gonna necessarily be things that people think about [...] I'm just gonna use [storage at] the range for an example. Because it's not something they typically do. They associate that with something white people do, and so that as an alternate way of storage is not gonna resonate with them." (ID21).

"That's ultimately why [organization] exists because queer people need a group of gun owners where they can talk about these things and not be regarded as crazy [...]." (ID28).


- Idea of belonging:
